- 1) Mr. Sullivan updated the Board on the solar project. Adam Teff, of Titan, Greenskies, informed Mr. Sullivan that the high school project is planned to be finished in May and the middle school project is planned to be finished in June.

#### 6. BUSINESS

Healthy Food Option - Approval of the Board of Education to Implement the Healthy Food Option During the Period of July 1, 2020 through June 30, 2021 and Allow Food Exemptions Pursuant to C.G.S. Section 10-215f, the Putnam Board of Education certifies that all food items offered for sale to students in the schools under its jurisdiction, and not exempted from the Connecticut Nutrition Standards published by the Connecticut State Department of Education, will comply with the Connecticut Nutrition Standards during the period of July 1, 2020, through June 30, 2021. This certification shall include all food offered for sale to students separately from reimbursable meals at all times and from all sources, including but not limited to, school stores, vending machines, school cafeterias, culinary programs and any fundraising activities on school premises sponsored by the school or by non-school organizations and groups.

The Putnam Board of Education will allow the sale to students of food items that do not meet the Connecticut Nutrition Standards and beverages not listed in Section 10-221q of the Connecticut General Statutes provided that the following conditions are met:

- 1) the sale is in connection with an event occurring after the end of the regular school day or on the weekend:
- 2) the sale is at the location of the event; and
- 3) the food and beverage items are not sold from a vending machine or school store.

An "event" is an occurrence that involves more than just a regularly scheduled practice, meeting, or extracurricular activity. For example, soccer games, school plays, and interscholastic debates are events but soccer practices, play rehearsals, and debate team meetings are not. The "regular school day" is the period from midnight before to 30 minutes after the end of the official school day. "Location" means where the event is being held.

Jeannie Dodd made a motion to adopt the Healthy Food Options as read. The motion was seconded by Jill Zangerl and passed unanimously.

# b. Approval of the 2020/2021 District Budget

Christopher Steinbrick made a motion to approve the 2020/2021 district budget as presented in the amount of \$19,448,920. The motion was seconded by Jill Zangerl and passed unanimously.
